Whereas, the intention of exclusion of the agricultural produce, namely, fruits and vegetables in relation to the market areas of all Regulated Market Committees (RMCs) in the State was published as required under section 3 read with sub-section (7) of section 4 of the Odisha Agricultural Produce Markets Act, 1956 (Odisha Act 3 of 1957) in the extraordinary issue No.1051 of the Odisha Gazette, dated the 2<sup>nd</sup> July, 2014 issued under the notification of the Government of Odisha in the Co-operation Department No.5139/Coop., dated the 1<sup>st</sup> July, 2014 inviting objection and suggestion from all persons likely to be affected thereby till expiry of a period of one month from the date of publication of the said notification in the Odisha Gazette;

And whereas, the objections and suggestions in respect of the said intention received within the stipulated period have been duly considered by the State Government;

Now, therefore, in exercise of the powers conferred by sub-section (7) of section 4 of the said Act, the State Government do hereby exclude the agricultural produce, namely, fruits and vegetables in relation to the market areas of all Regulated Market Committees (RMCs) in the State, specified as such agricultural produce by the State Government under sub-section (1) of section 4 of the said Act.
