## RESOLUTION

No.III-CR-7/12 7365 /Coop., Date: 23-8/2

Sub: National Agricultural Insurance Scheme (NAIS) – Implementation during the Kharif – 2012 Crop Season –Extension of cut-off date

In partial modification of Cooperation Department's Resolution No.6964/Coop., dated 07.08.2012 Government have been pleased to extend the last date i.e. the cut-off date for availing crop insurance by the non-loanee farmers under NAIS pertaining to Kharif-2012 season upto **31.08.2012** in pursuance of letter No.13011/30/9999-Credit-II dated 22.08.2012 of Govt. of India, Ministry of Agriculture, Department of Agriculture & Cooperation subject to the following conditions.

- (a) The extension would be applicable only to the crops sown / transplanted during the extension period i.e. after 31<sup>st</sup> July till expiry of the extended date.
- (b) The conditions of the crop on the date of submission of the proposal by the farmers at the Bank/PACS should be normal and the same will have to be confirmed in the proposal form and certified by appropriate Government Authority along with date of sowing / transplanting. Bank should verify the proposal form on these aspects before acceptance and would be retained with them for future reference.
- (c) The coverage during the extended period would be restricted to only normal coverage i.e. up to the value of Threshold Yield. No coverage beyond this value would be granted.
- 2. The Banks shall submit the declarations for extended period to AIC within 15<sup>th</sup> September 2012.
- 3. The Agriculture Insurance Company will issue necessary detailed operational modalities in this regard and give wide publicity to the extension of cut-off date for coverage of non-loanee farmers under the Scheme.
